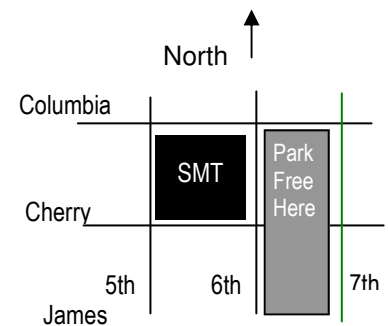

DIRECTIONS**



Seattle Municipal Tower (pictured on the right), located at
700 5th Ave (between Columbia St and Cherry St), Seattle

Entering on the 5th & Columbia side.

- Upon entering, Starbucks is on the left.
- On the right of Starbucks are four banks of elevators. Go to the first bank which is labeled for floors 40-62. These “express” elevators will take you to the 40th floor.
- Upon reaching the 40th floor, follow the sign for elevators to floors 41-62.
 - For the 51st floor :transfer to the elevators that go to floors **41-51** for the 51st floor, or
 - For the 58th floor :transfer to the elevators that go to floors **52-61** for the 60th floor

Access by Bus. For information on bus routes that service the downtown Seattle area, visit <http://transit.metrokc.gov> or call 206-553-3000.

Entering at the corner of 6th Ave & Cherry.

- Go on the pathway along the side of the building on Plaza Level 6.
- Follow the Accessible Route sign to an entrance. Upon entering, you will see stairs on your left and lounge chairs ahead.
- Go around a Seattle Metropolitan Credit Union machine to the elevators. Take the elevator down to Lobby Level P4.
- On P4, Key Bank is to your left. Go to the elevators ahead to the left. Take the elevators on the far left, for floors 40-62. These “express” elevators will take you to the 40th floor.
- Upon reaching the 40th floor, follow the sign for elevators to floors 41-62.
 - For the 51st floor :transfer to the elevators that go to floors **41-51** for the 51st floor, or
 - For the 58th floor :transfer to the elevators that go to floors **52-61** for the 60th floor

If you are driving:

Southbound on I-5:

- Take James Street exit (Exit #165A).
- Stay straight to go onto 6th Ave.
- Seattle Municipal Tower is on your right between Columbia and Cherry.
- Passenger drop-off point is at corner of 6th and Cherry.
- Other passenger drop-off points are on Columbia St, and on Cherry St.

Northbound on I-5:

- Take Dearborn/ James Street exit (Exit #164A).
- Take James St. off ramp; then turn left onto James St.
- Turn right onto 4th Ave.
- Turn right onto Marion St and go up the hill.
- Turn right onto 6th Ave.
- Seattle Municipal Tower is on your right between Columbia and Cherry.
- Passenger drop off point is at corner of 6th and Cherry.
- Other passenger drop-off points are on Columbia St and on Cherry St.

Parking is available at several public pay lots (over \$6/hr):

- Seattle Municipal Tower garage, between Columbia & Cherry: Enter on 6th Ave.
- SeaPark Garage, 6th between James & Cherry: Enter from any of the three streets.
- Fourth & Columbia Parking: Enter on Columbia between 4th & 5th Ave.
- United Parking 4th & Columbia: Enter on 4th Ave.
