Funding


ADS funds programs and services that help older people and adults with disabilities remain in their homes and communities of choice. ADS administers

approximately \$34 million in federal, state and local funds each year.



Advisory Council

Chartered under the Older Americans Act of 1965, twenty-seven members of the Seattle-King County Advisory Council on Aging and Disability Services guide planning and funding decisions. The Advisory Council has a significant role in advocating on behalf of older adults in King County.



Aging King County

The number of residents age 85+ is growing rapidly and is increasingly more racially and ethnically diverse. By 2025, nearly one-quarter of our county population will be over age 60.

Older adults tend to be healthier now than the generation before them, but many require special care at home. Approximately 80 percent of people serving as caregivers for older adults or adults with disabilities are family members.


