COVID-19

Meeting unexpected needs

Due to the COVID-19 pandemic, from March 2020 through 2021, staff worked remotely. ADS collaborated with Public Health—Seattle & King County, Washington State DSHS/ALTSA, and Department of Health to develop safety protocols to help ensure health and safety of clients, staff, and community partners; checked in regularly with those most vulnerable to dire outcomes; ensured that basic needs were met; developed strategies to address social isolation; and, when vaccines became available in 2021, ensured that more than 14,000 clients secured appointments.

Develop and strengthen community partnerships through presentations, media campaigns, and forums that increase awareness and promote healthy aging.

Community presentations were on hold due to COVID-19.

Expand evidence-based programming in King County.

Support Healthy

 Two facilitators were trained at two senior centers—Issaquah Senior Center and Enumclaw Senior Center.

Promote and institutionalize Universal Design in the built environment and ensure that new comprehensive and community plans incorporate age-friendly.

No NWUDC activities in 2021.

Increase understanding of consequences of social isolation and depression among decision makers, service providers, and consumers.

- ADS implemented social isolation awareness and social connectivity strategies, including distribution of technology to keep older adults connected during the pandemic.
- Distributed 151 wi-fi hotspots and over 150 tablets and other devices to community-based agencies.
- ADS partnered with King County CyberSeniors to train youth volunteers (12 in 2021) to assist older adults with digital skills.
- ADS partnered with Acquaint to help older adults connect and share through their remote social sharing platform.
- Distributed 5,000 drop cards to share information about social connectivity programs and reached approximately 2,254 viewers through the Age Friendly Close to Home program.

Objective

Coordinate annually with partners such as Public Health—Seattle & King County and the Alzheimer's Association to implement outreach strategies in the Washington State Alzheimer's Plan, with emphasis on communities of color.

Accomplishments

- Memory Sunday was observed on June 13, 2021, during Alzheimer's Awareness Month. Twenty-two congregations participated, representing an increase of 10 additional churches when compared to 2020. Due to the pandemic, services were held virtually. Participating churches were asked to post information about Alzheimer's and related dementias on their websites and in church newsletters, and provide a special prayer for caregivers.
- African American Caregivers Forum: Legacy of Love was held on November 13, 2021, during National Family Caregivers Awareness Month. About 90 caregivers and individuals participated in the 2-hour virtual event.
- Project ECHO -
- Dementia Friendly Communities Conference was held on September 13, 2021. Approximately 192 individuals pre-registered for the event and over 75 organizations were represented.
- SHARP Seattle Pilot: A local Sharing History through Active Reminiscence
 and Photo-imagery (SHARP) planning team was launched in April. SHARP is
 a technology-based, culturally relevant, celebratory, multimodal approach to
 maintaining brain health through physical, social, and reminiscence activity
 for older Black adults experiencing memory loss. The project is based on the
 original 2016 SHARP Study in Portland, OR, led by Dr. Raina Croff, Assistant
 Professor of Neurology at Oregon Health & Science University. A \$50K
 Seattle Department of Neighborhoods grant was awarded in October. The
 goal is to launch the pilot in the summer 2022.

Align ADS investments with King County Veterans, Seniors and Human Services Levy (VSHSL) to enhance the current aging network system.

- ADS and VSHSL staff met regularly throughout 2021.
- A draft map was developed which visualizes ADS and VSHSL funding investments throughout King County.

Seek additional funds to support Community Living Connections network.

Facilitate enhanced care planning across social service and healthcare systems.

- Six (6) agencies were supported through the VSHSL caregiver funding.
- ADS participated in monthly Community Information Exchange (AKA Connect2 Community) Network Partner workgroups and was also represented on the HealthierHere Governing Board and Connect2 Community Advisory Group.
- ADS implemented use of Unite Us platform in its Seattle Housing Authority program to test a closed loop referral technology platform, a key function of a Community Information Exchange.
- In late 2021, ADS participated in the development of the Connect2
 Community Technology Request for Proposal (RFP). The successful RFP
 bidder will implement and operate a technology solution to connect multiple existing or emerging technology platforms used by Connect2 Community partners, creating a "Unified Network."
- ADS continues to facilitate information sharing from/to Aging Network
 partners regarding Community Information Exchange development. Several
 Aging Network partners participate in Connect2 Community workgroups,
 and many have been able to utilize the Unite Us platform with HealthierHere
 Catalyst Fund awards.

Participate in advocacy efforts to increase the paid caregiver workforce.

Coordinate efforts to connect King County tribes and organizations to the Community Living Connections network.

Participate in annual 7.01 update meetings with tribal members and Office of Indian Policy staff.

Accomplishments

- Meetings were put on hold in 2021 to focus on pandemic emergency response efforts. ALTSA contracted American Indian Health Commission (AIHC) to work with AAAs/Community Living Connections programs. AIHC facilitated a training on Tribal Sovereignty and Working with Tribes and Urban Indian Health Programs with ADS staff February 2021.
- During 2021, two 701 meetings were held with tribal members (March 5 and June 4). An additional 701 meeting was held in April with Muckleshoot tribal members and DHSH Home and Community Services.
