PRESENTATION

"Hoarding: How Much is Too Much?" by Catherine "Cricket" Farr, MA., CMHC, GMH, Director of Housing Stabilization and Supports at Full Life Care. Catherine is also Co-Chair of the NW Hoarding Coalition with Ashley Craft, Clutter Support Coordinator at Seattle Housing Authority.

The presentation focused on identifying what is Hoarding Disorder (and what it is not), learning what you can do, (and not do) to help someone who hoards, and some tools you can use today. Conversation highlights included:

- We live in a consumer-oriented society which can contribute to the issue of hoarding.
- Situations vary; it can be because older adults downsize which requires the willingness to part with items, though there is a difference between high-clutter and hoarding.
- Ther is no data or programs on un-housed individuals, though conversations are taking place.
- This is a serious mental health disorder.
- The original research was not done with just older adults, but people of all ages.

RADI-AID for Corporations – Michael Adusah

- Fundraising ads are designed to pull at heart strings by highlighting deficits of individuals they try to raise funds for.
- The deficit approach flips the messaging for well-meaning campaigns.
- Legislation just passed "Nothing About Us Without Us" focuses on inclusion of the audience.
- Please note that the video is satirical in nature to address "What responsibility does corporations
 have in terms of telling nuanced stories about the world and their work with social
 responsibilities?"

II. REPORTS FROM COMMITTEES AND COUNCILS

Advocacy Committee - Diana Thompson

 The Skyline Skybridge Task Force is asking that the council write a letter of support for a skybridge to be built connecting the two buildings (Skyline Continuing Care Community building and Olympic Tower) across 8th avenue due to falls and injuries occurring when crossing the street. There are about 20 falls annually when crossing between the two buildings and one 9-1-1 call was made due to injuries related to a fall.

MOTION: A vote was taken to approve the writing of a letter of support for building a Skybridge between the Skyline Continuing Care Community Buildings on both sides of 8th Avenue.

Move to Accept: Alex O'Reilly

Seconded: Cindy Snyder

Outcome: The motion has passed, and Michal Adusah will draft a letter of support for the construction of a sky bridge being built.

• The Washington Association of Area Agencies on Aging (W4A) is getting \$12 million for nutrition, which will fund many programs all over the state.

Planning and Allocations Committee - Lorna Stone

- The Quarterly Community Review was held last week, and it would be useful for the council to discuss it as an agenda item.
- Hoping to hear more soon on the RFP and RFQs being put out now with the city budget freeze on grants over \$1 million.

VSHSL Board Seniors Committee

• No updates were provided this month.

NW Universal Design Council - Tom Minty

- A presentation was given yesterday on NWUDC at the South King Housing and Homeless Partners, and it was well received.
- The Steering Committee Meeting is next Tuesday at 2:00 p.m.

Mayor's Council on African American Elders - Pamela Williams

The February event for Black History Month included three programs serving African
Americans. Panelists included Margaret Boddie (Program Manager of African American Elders
Program Catholic Communities), Nacala Ayele (Board Chair of Harriet Tubman Center for
Health and Freedom Program), and Nathan Yamane (founder and Executive Director of
Health Heart N' Soul Hospice). This was our first hybrid meeting of 2024 and there were over
35 attendees.

• The March 15 meeting will have representatives from the Centers for Medicare and Medicaid with presentation on those services and Marketplace health insurance.

Age-Friendly Seattle (AFS) – Michael Adusah

- The Social Connectivity Network is being launched to bring together people to discuss current efforts to help keep older adults connected.
- The next Civic Coffees are being held at CISC and cover how to spot fake news and summer entertainment opportunities.
- The public-facing Anti-Ageism Trainings are heading into production, and internet rollout with COS employees.
- Debrief discussions scheduled with Parks and Animal Shelter staff.
- The AFS Strategic Framework is now posted online.

III. REPORTS FROM AAA PARTNERS

King County Department of Community and Human Services – Traci Adair

- VSHSL Board will be meeting next month.
- VSHSL Older Adult and Elder Aging Team launched the first procurement from the renewed levy (the Senior Center Procurement). The procurement closes next week, then we'll know which centers come into the King County Senior Center Network.
- Procurement for Villages, Caregiving Supports, and Health Promotion are rolling out.
- Coordinating with Age Friendly on Emergency Outreach and supplying vulnerable older adults
 with emergency supplies through a Department of Health grant. This work is being
 highlighted at the American Society on Aging Conference in March.

Public Health Seattle-King County

No updates were provided this month.

Sound Cities Association - Andi Parnell

• Many city leaders are headed to the National League of Cities Conference to talk about Health and Human Services, Transportation, and Housing.

- Maggie Thompson has accepted the permanent role as HSD Deputy Director. Division
 Directors (Safe and Thriving, Youth and Family Services and ADS) will continue to report to
 the Interim Deputy Director, Anne Lee.

- In addition to the hiring freeze, the city is reviewing all contracts over \$1 million as part of their budget gap analysis.
